CURRENT PROJECTS

The HOA Board and Hershey's Mill Management (HMM) work together to address the many needs of our community. Recent activities include:

- The HOA has secured a settlement from Dupont as a result of the use of the Imprelis weed suppression product that damaged White Pine and Spruce trees within the community. Tree replacement is still ongoing and we have retained the arborist Rockwell Associates to develop a master landscaping design plan for the community going forward. This plan focuses on both aesthetics and prudent plant/tree selection for climate, soil conditions, and projected growth patterns.
- Video inspection of the underground storm water management system is currently taking place to determine the condition and ensure structural integrity of this often unnoticed but key community component.
- A Reserve Fund Study is underway to gauge the longterm financial health of the Capital Reserve Fund. The study will update the original 2009 report and will estimate what the long-term costs are to maintain community property such as sidewalks, playgrounds, community entrances and tennis courts. This allows the HOA to ensure the reserve fund is adequately funded for today and for the future.
